

Techspectations – Terms & Conditions

1. Applicability

- 1.1. These Terms & Conditions (“Terms”) govern attendance, participation, and use of services provided in connection with Manorama Online Techspectations (the “Event”).
- 1.2. Attendance at or participation in the Event or related activities (including registration via the Manorama Online / QuicKerala platform) signifies that you (“Attendee”, “Participant”, “You”) have read, understood, and agree to be bound by:

2. Registration and Tickets

- 2.1. Tickets are sold subject to availability and must be fully paid before issuance.
- 2.2. Registration is confirmed only upon receipt of full payment and issuance of a valid ticket. Manorama Online reserves the right to cancel incomplete or unpaid registrations.
- 2.3. Tickets are non-transferable, non-refundable, and non-cancelable except at the sole discretion of Manorama Online.
- 2.4. Manorama Online may refuse or revoke tickets at any time for reasons including breach of these Terms or inappropriate conduct.

3. Changes to the Event

- 3.1. Manorama Online reserves the right to alter, cancel, postpone, reschedule, or relocate the Event (or any part of it) at any time.
- 3.2. Manorama Online is not responsible for any direct or indirect losses or costs (including travel, accommodation, or related expenses) arising out of such changes.

4. Code of Conduct and Safety

- 4.1. All attendees must comply with all venue rules and directions from Manorama Online, venue staff, or security personnel.
- 4.2. Disruptive, abusive, discriminatory, unlawful, or unsafe behavior may result in immediate removal without refund.
- 4.3. Attendees are responsible for their own property; Manorama Online is not liable for loss, theft, or damage of personal items.

5. Content and Intellectual Property

- 5.1. All event content (presentations, workshops, recordings, materials) is owned by Manorama Online or its partners and is protected by intellectual property law.
- 5.2. Attendees may not reproduce, distribute, modify, broadcast, or commercially exploit any Event content without prior written permission.
- 5.3. Unauthorized filming, recording, or streaming of sessions is prohibited unless expressly permitted in writing.

6. Privacy and Use of Personal Information

- 6.1. By registering, you consent to Manorama Online & event partners collecting, storing, and using personal data for event administration, communications, analytics, and marketing.
- 6.2. Personal data may be shared with third-party service providers and solely for event delivery and related updates.

7. Liability and Indemnity

- 7.1. To the maximum extent permitted under applicable law, Manorama Online's total liability arising out of or relating to these Terms or the Event is limited to a nominal amount (e.g., the ticket price paid).
- 7.2. In no event shall Manorama Online be liable for indirect, incidental, consequential, punitive, or special damages (including loss of revenue, profits, data, or reputation).
- 7.3. You agree to indemnify and hold harmless Manorama Online and its affiliates from any claims, losses, damages, expenses, or liabilities arising from your conduct, breach of these Terms, or participation in the Event.

8. Compliance with Laws

- 8.1. Attendees agree to comply with all applicable laws, regulations, and venue policies (including health and safety requirements).
- 8.2. You represent that you are at least 18 years of age and have the legal capacity to enter into these Terms.

9. Force Majeure

- 9.1. Manorama Online shall not be liable for any failure or delay in performance due to causes beyond its reasonable control (including natural disasters, pandemics, acts of government, labor disputes, internet failures, or other unforeseen events).

10. Governing Law

- 10.1. These Terms shall be governed by and construed in accordance with the laws of India.
- 10.2. Any dispute arising from these Terms or the Event shall be subject to the exclusive jurisdiction of the High Court of Kerala, India.
